Engineering thermal plastic above ground meter box housing, 15mm V110 KSMT plastic bodied water meter 114mm long with non-return valve and fixed one pulse per 1/2 litre output facility, of the semi-positive rotary piston type and approved under the trade Metrology Act and Regulations and to SABS 1529-1:1994 class C specifications, complete with unique high quality plastic three-way (open/closed/trickle flow) ball valve fitted upstream of the meter and a similar two-way (open/closed) consumer ball valve  
Complete with 25mm HDPE internal piping and 3/4" (20mm) BSP glass nylon reinforced female connectors.

Above Ground Meter Box is manufactured of non-metallic, UV resistant material, housing a plastic V130T Multi-Range (15/20mm) water meter with 25mm fusion welded pipes and fittings all within the box. The reading slot is covered by a flip back cover. The plastic V130T Manifold Meter is approved to Class B 15mm specification and has a maximum flow rate of a 20mm meter and also has an approved pulse output of 2 pulses per litre.

The concept of raising the meter installation off the ground makes the meter easier to read plus gives the advantage of freedom from flooding, and dirt and mud obscuring the counter reading. By pre-plumbing and pressure testing the whole unit for leaks it is ready for installation. The municipal 3 way trickle flow ball valve is actuated from the outside using a 10mm Allen key. The inlet and outlet connections are 20mm (3/4") glass nylon reinforced female threaded for use with 20mm male threaded pipe adaptors (not supplied)
