When they experience any challenges they can go to: business.support:csd@treasury.gov.za.To be considered for transactions below R30 000,service providers/suppliers must when uploading their information at categories, must insert Lesedi as a point of delivery.

Designated groups in terms of the Preferential Procurement Regulations of 2017, Section 4(i) of Government Gazette No.40553 within Lesedi and township based are encourage to apply, which includes the following:

- an EME or QSE;
 - an EME or QSE which is at least 51% owned by black people;
 - an EME or QSE which is at least 51% owned by black people who are youth;
 - an EME or QSE which is at least 51% owned by black people who are women;
 - an EME or QSE which is at least 51% owned by black people with disabilities;
 - an EME or QSE which is 51% owned by black people living in rural or underdeveloped areas or townships;
 - a cooperative which is at least 51% owned by black people;
- an EME or QSE which is at least 51% owned by black people who are military veterans; and
- an EME or QSE which is at least 51% owned by black people who are military veterans.
