Tender documents, together with the terms of reference, which are important for the preparation of the proposal/tender, will be available from Ms. Sibulelo Nxathi at SCM office at the Municipality, Heidelberg, as from the 04 May 2018 for a non-refundable fee of R 1500.00 payable at the rates and taxes hall during office hours Monday – Friday, 08:00 – 15:00, only cash or EFT will be accepted. Tender documents can also be downloaded for free on the E-Tender portal ([www.etenders.gov.za](http://www.etenders.gov.za)).

Bidders must note that certain works under this Bid may only be constructed using labour-based construction methods and must limit the utilization of their permanently employed personnel to Key Personnel and all other personnel and labourers must be recruited locally.

Bidders must be registered with the Construction Industry Development Board (CIDB) in a contractor grading designation determined in accordance with the sum tendered for a **5 CE** class of construction work. Enterprises who have a grading may submit bids.

A compulsory site clarification meeting will be held at 10:00 on Monday, 07 May 2018. Prospective bidders are requested to meet on the said date and time at the Infrastructure Services Boardroom. Bid documentation will not be available at the compulsory site clarification meeting and the Employer's Agent will not be available for inspection purposes on any other date and time.

Bids are to be completed in accordance with the conditions and bid rules contained in the bid documents and supporting documents must be sealed and externally endorsed WITH THE CONTRACT NUMBER and DESCRIPTION and placed in the tender box, at the Supply Chain Management Department, Municipal Building c/o HF Verwoerd and Du Preez Street, Heidelberg, during office hours Monday-Friday, 07:30 – 16:00. The tender closes at 12:00 on Tuesday, 15 May 2018. Bids will be opened immediately thereafter, in public, in the Boardroom Room, 1<sup>st</sup> Floor, at the above-mentioned address. All bids shall be valid for 90 days as from the closing date of bids. No late, e-mailed or faxed bids will be considered. All objections and complaints must be lodged within 14 days and in writing to the Municipal Manager's Office.

Bidder's attention is specifically drawn to the provisions of the rules which are included in the bid documents. The Lesedi Local Municipality (LLM) reserves the right not to award to the lowest priced proposal, it normally awards the contract to the tenderer who proves to be fully capable of handling the contract and whose proposal is technically acceptable, has meaningful empowerment credentials and/or is financially advantageous to the Lesedi Local Municipality. Bids completed in pencil will be regarded as invalid bids.

Only bidders who score 70 points or more for functionality will be further evaluated on Price and B-BBEE.

The bid is expected to be below R50 Million and therefore the 80/20 preference procurement point system will apply and preference will be given to bidders who are able to demonstrate the following:

All service providers must submit their B-BBEE Verification Certificate from Verification Agencies accredited by the South African Accreditation Systems (SANAS) or a Registered Auditor approved by the Independent Regulatory Board (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) in order to claim preference points.

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations. Additionally, no contract shall be concluded with any bidder, whose municipal rates and taxes and service charges are in arrears. All bidders must ensure that they are registered on the National Treasury Central Supplier Database via the following link:[business.support@csd.gov.za](mailto:business.support@csd.gov.za). No business will be conducted with any person who is not registered on this database.
