Notice is hereby given that in terms of Section 116(3) of the Local Government: Municipal Finance Management Act, Act 56 of 2003, the Lesedi Local Municipality intends to extend the contract of NDK (Pty) Ltd in respect of tender 18/2012 relating to the appointment of the designated Municipal Valuer as required by section 33 of the Local Government: Municipal Property Rates Act, 2004 as amended for the compilation and maintenance of the general and supplementary valuation rolls and all other municipal valuation related services.
