T1.1 TENDER NOTICE AND INVITATION TO TENDER

Lesedi Local Municipality invites tenders for the Upgrading of a bulk water line at Kwazenzele development.

It is estimated that tenderers should have a CIDB contractor grading of 5 CE or 4 CE PE or higher. In cases of a Joint Venture, every member of the Joint Venture should be registered with the CIDB and the lead partner, should have a Contractor grading designation in the 5 CE or 4 CE PE class of construction work. The combined Contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher to a contractor grading designation determined in accordance with the sum tendered for a 4 CE PE class of construction work, or a value determined in accordance with Regulation 25 (1B) of 25 (7A) of the Construction Industry Development Regulations.

Bid documents will be obtainable from the Supply Chain Offices on payment of a cash non-refundable document fee of R 1696.00 per document from the offices of the Lesedi Local Municipality, 1 HF Verwoerd Street, Civic Centre Building, Heidelberg, 1441. Documents will be available from the 18 November 2015 at 12h00, thereafter during office hours from 08:30 to 13h00 and 13h45 to 15h15 weekdays. No documents will be available at the site inspection meeting. A Compulsory Site Inspection meeting with the representatives of the Employer will be held on the 18 November 2015 at 10h00 at the offices of Lesedi in the Infrastructure Services Boardroom.

The completed proposals must be submitted in a sealed envelope marked" Functionality". The completed tender document must be submitted in a separate sealed envelope clearly marked "Price". Both envelopes must be placed in one single sealed envelope marked:-TENDER NO: 11/2015: UPGRADING OF A BULK WATER LINE AT KWAZENZELE DEVELOPMENT

Tenders are to be completed in black ink and completed in accordance with the conditions and rules contained in the tender documents. Tenders and relevant documents must be deposited in the tender box situated at the Development and Planning Department, Municipal Building, 1 HF Verwoerd St, Civic Centre Building, Heidelberg, 1441 not later than 12h00 on the 25 November 2015. Tenders will immediately be opened in public. Tenders shall remain valid for a period of 90 days from the closing date. Telegraphic, telephonic, fax, telex, e-mail or late tenders will not be accepted. Tenders will be evaluated in terms of the Supply Chain Management policy of the Lesedi Local Municipality.

The LLM (Lesedi Local Municipality) reserves the right not to accept the lowest priced proposal or any proposal in part or in whole. It normally awards the contract to the tenderer who proves to be fully capable of handling the contract and whose proposal is technically acceptable, has meaningful empowerment credentials and / or financially advantageous to the LLM. LLM reserves the right to negotiate rates, for purposes of creating uniformity and the tenderer, by responding to this tender, agrees to abide by such negotiated rate which may be changed from time to time by agreement between the parties. Any bid not suitably endorsed or comprehensively completed, as well as bids completed in pencil will be regarded as invalid bids. All objections and complaints must be lodged within 14 days and in writing to the municipal's manager's office.

Only bidders who score 60% or more for functionality will be further evaluated on both Price and B-BBEE points.

The 90/10 preference procurement point system will apply and preference will be given to bidders who are able to demonstrate the following:-

a) Price

90 points

b) B-BBEE Status Level of Contribution

10 points

accredited by the South African Accreditation Systems (SANAS) or Registered Auditor approved by the Independent Regulatory Board (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) in order to claim preference points.

It is a condition of bid that the taxes of the successful bidder <u>must</u> be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations. Tenderers should submit an Original SARS Tax Clearance Certificate. Additionally, no contract shall be concluded with any bidder, whose municipal rates and taxes and service charges are in arrears.
