3. If vehicles are rented, lease agreement copy
4. Invoices relating to work of the same magnitude
5. Must be registered on CSD(Central Supplier Database)
6. Original valid tax clearance certificate/Pin provided by Sars
7. MBD Forms (MBD 2, MBD 4, MBD 6.1, MBD 8, MBD 9, Clearance Certificate for Water & Lights)
8. Latest municipal account

Bidders who did not submit an original or certified copy of their BBBEE Certificate will not be allocated preference points and will only be evaluated on price.
