## **SPECIFICATIONS**

200 x 15mm Above Ground Polymer Water Meter box Polymer multipurpose above ground meter box housing a 15mm semi-positive rotary piston Class “C” water meter. A 3-way ballcock is located upstream of the water meter, and a 2-way ballcock with exposed handle for the consumer is located downstream of the meter, sliding couplings connect the inlet and outlet of the water meter and allow replacement; internal piping is Ø25mm HDPE and joints are fusion welded. The meter box inlet and outlets are Ø20mm (3/4”) BSP female Polymer threads.

A sliding cover allows reading of the water meter cyclometer and the serial number. In the case of Pre-Paid, the electronic reading can also be seen. A dual key operated locking mechanism allows removal of the top half of the meter box for maintenance.
