The Lesedi Local Municipality hereby invites bids for the Supply, delivery, off-loading, and fitment of tyres for a period of 36 months.

Tender documents, together with the terms of reference, which are important for the preparation of the tender are accessible for free on the E-Tender portal ([www.etenders.gov.za](http://www.etenders.gov.za)) as from 01 October 2020.

The completed bids must be submitted in a sealed envelope marked: **"TENDER NO: 06/2020: SUPPLY, DELIVERY, OFF-LOADING, AND FITMENT OF TYRES FOR A PERIOD OF 36 MONTHS."**

Bids must be placed in the tender box situated at the Supply Chain Management Department, Municipal Building, c/o H F Verwoerd and Du Preez Street , Heidelberg, during office hours Monday – Friday, 07:30 – 16:00. The tender closes on the 30 October 2020 at 12:00. No late, or e-mailed or faxed bids will be considered. All objections and complaints must be lodged within 14 days and in writing to the municipal manager's office.

**NB: 1) IN AN EFFORT TO CURB THE SPREAD OF COVID-19, THERE WILL BE NO BRIEFING SESSION.**

**2) IN ACCORDANCE WITH THE DISASTER MANAGEMENT ACT, WHICH PROHIBITS GATHERINGS OF MORE THAN 50 PEOPLE, THE TENDER OPENING WILL BE LIMITED TO NOT MORE THAN 50 PEOPLE AS PER COVID-19 DISASTER MANAGEMENT REGULATIONS.**

**3) BIDDERS ARE ALSO REQUESTED TO OBEY ALL COVID-19 PROTOCOLS AT MUNICIPAL OFFICES WHEN SUBMITTING BIDS.**

Bidder's attention is specifically drawn to the provisions of the rules which are included in the bid documents. The Lesedi Local Municipality (LLM) reserves the right not to award to the lowest priced proposal, it normally awards the contract to the tenderer who proves to be fully capable of handling the contract and whose proposal is technically acceptable, has meaningful empowerment credentials and/or is financially advantageous to the LLM. Bids completed in pencil will be regarded as invalid bids.

Only bidders who score 70 points or more for functionality will be further evaluated on both Price and B-BBEE points.


The 80/20 preference procurement point system will apply and preference will be given to bidders who are able to demonstrate the following:

All service providers must submit their B-BBEE Verification Certificate from Verification Agencies accredited by the South African Accreditation Systems (SANAS) or a Registered Auditor approved by the Independent Regulatory Board (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) in order to claim preference points.

It is compulsory that the taxes of the successful bidder must be in order or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations. Additionally, no contract shall be concluded with any bidder, whose municipal rates and taxes and service charges are in arrears for more than three months.
